Terms and Conditions

Fees quoted are inclusive of learning materials and resources unless specified otherwise. Course duration and hours are indicative only and depend on individual circumstances, for example students undertaking RPL (recognition of prior learning) or receiving credit transfers may require only a shorter period of time to complete. The student tuition fees as published are subject to change given individual circumstances at enrolment. Eligibility for the Victoria Government Skills First Program will be assessed at enrolment. Subsidised training is delivered with Victoria and Commonwealth Government funding. Enrolling in courses under Skills First program funding may impact further access to Government subsidised training.



Eligibility for Skills First

In order to be an Eligible Individual for Skills First funding an individual MUST meet the following criteria:

- Have a physical presence in Victoria while undertaking the Qualification.
- Meet citizenship/residency requirements, i.e. be an Australian citizen, or holder of permanent visa, or a New Zealand citizen.
- Must meet 'up skilling' requirements, i.e. commence a course at a higher AQF level than is currently held.

In addition to meeting the above requirements, an individual is only eligible to:

- Commence a maximum of 2 government subsidised courses in a calendar a year.
- Undertake a maximum of 2 government subsidised courses at any one time.
- Commence a maximum of 2 government subsidised courses at the same level within the AQF in your lifetime (Qualifications listed on the Foundation Skills list will not be counted towards the AQF level requirement, the Foundation Skills qualifications are included in the 2 qualification a year guideline).
- Commence a maximum of 2 government subsidised accredited courses with the title "Course in ... "in your lifetime.

Eligibility Exemptions for Skills First

The following individuals referred to training under particular initiatives may not be required to meet certain aspects of the eligibility criteria:

- Asylum Seekers
- Latrobe Valley Initiative
- Back to Work Scheme

Please note from time to time the Government will introduce or vary the initiatives and eligibility criteria. Eligibility for Skills First program will be assessed at time of enrolment.

The following individuals are not eligible for training subsidised through the Skills First Program:

- A student enrolled in a school (excluding a school based Apprentice/Trainee).
- A prisoner held at a prison
- A person who is detained under the Mental Health Act 1986 (Vic)
- A person who is detained (other than on weekend detention) under the Children, Youth and Families Act 2005 (Vic) or the Sentencing Act 1991 (Vic) or who is held on remand in one or more of the following youth justice facilities:
 - Malmsbury Juvenile Justice Centre;
 - Parkville Youth Residential Centre; or
 - Melbourne Youth Justice Centre.

Fee-for-Service

Fee-for-service tuition fee rates apply to applicants who do not meet the Skills First funding eligibility criteria. In accordance with the fee policy of TAIE, all domestic students will be required to pay tuition fees on equal monthly instalment basis with the first month's fees due prior to commencement. The monthly fee payable rate is determined based on the total course fee and expected course duration. Following commencement, domestic students will be billed and invoiced, progressively on a monthly basis throughout the duration of their study and for each monthly invoice cycle, they will be required to pay no more than \$1,500 in advance for tuition fee and services. The pre-course commencement and progressive invoicing fees will be such that at any given time, the total amount required to be paid which is attributable to tuition or other services yet to be delivered to the student is no more than \$1,500. Any amounts in excess of this \$1,500 will be deferred until course completion where such amount will become payable and due. **Refer monthly tuition fee payable column above.**

What is RPL?

RPL refers to recognition of prior learning and is the process whereby a person's skills and experience is matched and assessed the studies and qualification which you are enrolling into. More information can be found in the [Skills Recognition](#) page on TAIE's website at www.taie.com.au. The cost of RPL if not for the whole qualification, is \$250 per unit of competency. RPL applicants will be required to pay an initial amount of \$250 with the balance due upon completion of the RPL process. Qualification certificates and transcripts will be released upon receipt of all outstanding amounts.

Refunds
